The Cisco® Aironet® 4800 Access Point is packed with an abundance of features that offer users a better experience, top-notch security, and high-speed connectivity. The Aironet 4800 makes troubleshooting easier and enhances the context shown in Cisco DNA Assurance.

The access point's functionality is spread out over four internal radios, so these features run simultaneously over your network. The Aironet 4800 expands the current rich capabilities of our current Aironet portfolio (with features such as built-in Flexible Radio Assignment, Hyperlocation, and Bluetooth Low Energy [BLE]) and adds a fourth internal radio to provide rich performance and location and security analytics. With more radios embedded in the access point, your wireless network achieves higher security and data analysis without degrading performance—you'll never again have to trade security for network performance.

What does this mean?

For starters, having a fourth radio allows the BLE and security monitoring functions to run on their own individual radios, while the other two radios tend to the business of providing exceptional Wi-Fi. This level of visibility provides IT more powerful capabilities to help ensure the user experience for productivity and engagement.

The capabilities of the Aironet 4800 include features that the competition can't measure up to. From the built-in Intelligent Capture that provides enhanced issue detection and root cause analysis to on-demand, real-time troubleshooting to in-service access point monitoring with packet capture, the Aironet 4800 protects the network like no other. Want proof? Intelligent Capture is two to three times faster than the competition in client location tracking and client onboarding and is three to five times faster when it comes to client RF stats.

An integrated radio for Hyperlocation provides more granular data by enabling device monitoring and tracking to within 3 meters—the best in the industry. With such pinpoint accuracy, you can say goodbye to equipment that mysteriously disappears from the office. How? Hyperlocation allows for historical monitoring of asset location. If a tagged device disappears, you can go back and figure out when it left the area.

Hyperlocation can also help your employees and guests find their way through your building with the appenabled indoor wayfinding and navigation features. These features enable a mobile client to query its own location for indoor wayfinding. In addition, an app can be created that will provide a Point Of Information (POI) and detect when the user is present.

Another great use for Hyperlocation is location analytics. You can get information on devices, dwell time, and path analytics, among other data, for any device that connects to your network. By combing this data with Operation Insights, you can make better business decisions while maintaining an always-on, always-available user experience. For instance, you can determine that one part of the office is never being used at certain times, and take advantage of this knowledge by making sure the lights are off, thus reducing energy use and saving money.

Before the Hyperlocation feature was embedded in the Aironet 4800, there was no way get this feature on a Cisco 802.11ac Wave 2 access point.

With a radio dedicated solely to security, the Aironet 4800 is a sentry designed to stop any rogue agents attempting to gain access to your network, 24 hours a day, 7 days a week. This dedicated radio constantly monitors the wireless network, looking for anything that can cause a threat. And with the radio's ability to pinpoint causes for concern less than 3 meters away, you know you're getting security that finds the little things before they can grow into big problems. The Aironet 4800 protects the network while predicting and responding to issues and threats faster.

The Aironet 4800 also offers real-time troubleshooting. It does this by sniffing and decrypting live traffic using one of the access point's four radios. Similarly, due to the device's live monitoring of critical radio statistics, such as MU-MIMO, data rates, channel utilization, and others, it's able to quickly detect many types of wireless security threats. These capabilities, together with monitoring of critical assets such as Received Signal Strength Indication (RSSI), packet retry, and more, are examples of how the Aironet 4800 access point focuses on the health of your network.

The Aironet 4800 does more than guard the network. It also detects issues and the causes of poor client performance. Solving roaming issues and finding root causes for poorly performing clients such as "sticky clients" are handled by tracking pre- and post-associated radio behavior via client scanning.

When the Aironet 4800 is paired with Cisco DNA Assurance, a whole host of features open up for the network. For example, once an issue is discovered, the network administrator is able to go back in time (up to 7 days) and investigate the root cause of the problem. From there, suggested actions are offered to fix the issue.

With the Aironet 4800, you can secure remote workers or the micro-office. Any Cisco Aironet or Catalyst access point can function as an OfficeExtend Access Point (OEAP). With an OEAP, an employee at home or in a temporary micro-office will have access to the corporate SSID and the corporate network without the need to set up a VPN or have any advanced technical know-how.

Cisco User Defined Network, a feature available in Cisco DNA Center, allows IT to give end users control of their very own wireless network partition on a shared network. End users can then remotely and securely deploy their devices on this network. Perfect for university dormitories or extended hospital stays, Cisco User Defined Network grants both device security and control, allowing each user to choose who can connect to their network (Available second half of calendar year 2020.).

The Wi-Fi 6 readiness dashboard is a new dashboard in the Assurance menu of Cisco DNA Center. It will look through the inventory of all devices on the network and verify device, software, and client compatibility for the new Wi-Fi 6 standard. After upgrading, advanced wireless analytics will indicate performance and capacity gains as a result of the Wi-Fi 6 deployment. This is an incredible tool that will help your team define where and how the wireless network should be upgraded. It will also give you insights into the access point distribution by protocol (802.11 ac/n/abg), wireless airtime efficiency by protocol, and granular performance metrics.

802.11ac Wave 2 and beyond

The Aironet 4800 extends 802.11ac speed and features to a new generation of smartphones, tablets, and high-performance laptops, providing a greater end-user experience. Whether your project involves wholesale changes to your current wireless network or upgrading your legacy Wi-Fi deployments (802.11a/b/g/n/ac Wave 1 deployments), the Aironet 4800 can handle the job.

The Aironet 4800 supports 802.11ac Wave 2, providing a theoretical connection rate of up to 5.2 Gbps—that's roughly four times the rate offered by today's high-end 802.11ac access points. The boost helps you stay ahead of the performance and bandwidth expectations of today's mobile worker, who usually uses multiple Wi-Fi devices instead of just one. As such, users are adding proportionally larger traffic loads to the wireless LAN, which has outpaced Ethernet as the default enterprise access network.

High-density experience

Building on the Aironet heritage of RF excellence, the Cisco Aironet 4800 Access Point runs on a purpose-built, innovative chipset with a best-in-class RF architecture. This chipset provides a high-density experience for enterprise networks designed for mission-critical, high-performance applications. The Aironet 4800 is part of Cisco's flagship portfolio of 802.11ac-enabled access points, delivering a robust mobility experience. It features 802.11ac Wave 2 with 4x4 MU-MIMO technology supporting three spatial streams. MU-MIMO enables access points to split spatial streams between client devices to maximize throughput.

With four radios built into each access point, the Aironet 4800 is more versatile than any access point currently on the market. Two of the four radios are outfitted with Flexible Radio Assignment, which means that the access points automatically self-optimize to better serve the environment. For example, one of the radios broadcasts its signal on the 5-GHz channel and the other sends out a 2.4-GHz signal. The access point understands the wireless environment and will automatically switch the 2.4-GHz signal to a 5-GHz signal, increasing the reliability of your users' Wi-Fi use. This setting automatically works in reverse too: the access point can recognize that the RF environment has changed and revert back to its original configuration.

The Aironet 4800 also dynamically changes the radio settings based on the wireless environment.

- **Optimized access point roaming** helps ensure that client devices associate with the access point in their coverage range that offers the fastest data rate available.
- **Cisco ClientLink 4.0** improves downlink performance to all mobile devices, including one-, two-, and three-spatial-stream devices on 802.11a/b/g/n/ac. At the same time, the technology improves battery life on mobile devices.
- **Cisco CleanAir** is enhanced with 160-MHz channel support. It delivers proactive, high-speed spectrum intelligence across 20-, 40-, 80-, and 160-MHz-wide channels to combat performance problems due to wireless interference.

- MIMO equalization capabilities optimize uplink performance and reliability by reducing the impact of signal fade.




Figure 2. Aironet 4800 access point coverage radius

Licensing

In order to connect any access points to the **controller**, Cisco DNA software subscriptions are required. Every access point connecting to Catalyst 9800 requires a Cisco DNA subscription license to be entitled to connect to the controller.




Figure 3.Determining license requirements for access points connecting to Cisco Catalyst 9800 Series Wireless Controllers

Access points connecting to a Cisco Catalyst 9800 Series controller have new and simplified software subscription packages.

They can support both tiers of Cisco DNA software: Cisco DNA Essentials and Cisco DNA Advantage.

Cisco DNA software subscriptions provide Cisco innovations on the access point. They also include perpetual Network Essentials and Network Advantage licensing options, which cover wireless fundamentals such as 802.1X authentication, Quality of Service (QoS), and Plug and Play (PnP); telemetry and visibility; and Single Sign-On (SSO), as well as security controls.

Cisco DNA subscription software has to be purchased for a 3-, 5-, or 7-year subscription term. If not renewed by the end of the term, Cisco DNA features will expire, whereas Network Essentials and Network Advantage features will remain.

Two modes of licensing are available:

- Smart Licensing (SL) simplifies and adds flexibility to licensing. It is:
 - Simple: Procure, deploy, and manage licenses easily. Devices self-register, removing the need for Product Activation Keys (PAKs).
 - Flexible: Pool license entitlements in a single account. Move licenses freely through the network, wherever you need them.
 - Smart: Manage your license deployments with real-time visibility into ownership and consumption.
- Specific License Reservation (SLR) is a feature used in highly secure networks. It provides a method for
 customers to deploy a software license on a device (product instance) without communicating usage
 information to Cisco. There is no communication with Cisco or a satellite. The licenses are reserved for
 every controller. It is node-based licensing.

Four levels of license are supported on the **Cisco Catalyst 9800 Series Wireless Controllers.** The controllers can be configured to function at any one of the four levels.

- Cisco DNA Essentials: At this level the Cisco DNA Essentials feature set will be supported.
- Cisco DNA Advantage: At this level the Cisco DNA Advantage feature set will be supported.
- NE: At this level the Network Essentials feature set will be supported.
- NA: At this level the Network Advantage feature set will be supported.

For customers who purchase Cisco DNA Essentials, Network Essentials will be supported and will continue to function even after term expiration. And for customers who purchase Cisco DNA Advantage, Network Advantage will be supported and will continue to function even after term expiration.

Initial bootup of the controller will be at the Cisco DNA Advantage level.
